# WHAT DO WE DO WITH YOUR DATA?

When you purchase something from our store, part of the buying and selling process is collecting the personal information you share with us, such as your name, address and email address. When you browse our website, we automatically receive your IP address, which provides us with information about your browser and your operating system. Internet Marketing (if applicable): With your consent, we may send you emails with information about our store, new products and other news.

# PERMISSION TO USE PERSONAL DATA?

#### How do you get permission to use my data?

When you provide us with personal data to conclude a transaction, your credit card is verified, you place an order, specify the place of delivery or return the goods, we assume that you consent to us collecting and using it only for this specific purpose. If we want to obtain your personal data for other purposes, such as for marketing purposes, we will either ask for your consent directly or give you the opportunity to decline.

#### How can I withdraw my permit?

# DISCLOSURE TO USE PERSONAL DATA

# THIRD PARTY SERVICES
